MACRO-ECONOMIC OVERVIEW

This review of corporate change in Cumbria has been compiled at a time of unprecedented national and international change marked by uncertainty at both levels. On the international scale, the threat of trade conflicts combined with political tensions affecting oil-producing countries has adversely affected global growth. These global factors have combined with the uncertainties surrounding BREXIT to dampen confidence and lower investment across the Eurozone, while in the UK the uncertain outcome of Brexit looms large in any interpretation of trends in national economic indicators.

The UK Economy and Brexit

In the context of Brexit uncertainties, UK GDP grew in the first quarter of 2019 by 0.5% compared to the previous quarter. However, analysts suggest that this overstates the underlying trend due to the effects of the build-up of inventories in the manufacturing sector by some companies ahead of the presumed Brexit deadline in March 2019. Evidence to support this claim is now widespread. In April 2019, the analysts IHS Market reported that according to the Purchasing Managers Index (PMI)¹, the rate of increase in stocks of purchases in the UK reached a record high for three consecutive months to March. Stocks of finished goods were also at high levels. This ties in with other evidence from the Bank of England Survey reported on 2nd June 2019. The Bank's Agents Survey of 283 businesses indicated that 40% of respondents had built up stocks in the run-up to the end of March. The level of stockpiling was not just limited to large corporates with international production sites and supply chains that cut across borders. A CBI Quarterly SME Trends Survey² of 252 small and medium-sized manufacturers reported on 1st May 2019 that stocks of raw material (+33%) and finished goods (+18%) grew at the fastest rate on record.

The point of debate in the second quarter of 2019 has been the extent to which firms will now de-stock with dampening effects on growth. This expectation has been fuelled by early GDP estimates for the quarter. In the three months to May 2019, for instance, the ONS report that manufacturing output was up only 0.3% on the previous 3 months. The Bank of England Agent's Survey also indicated that around a third of survey respondents planned to run down the stocks built up in the first quarter. It remains to be seen, however, how firms will now respond to the impending Brexit deadline in October 2019.

BREXIT, however, has other implications for the UK economy beyond manufacturing, some of which are perhaps unexpected. Despite uncertainties generated by political turmoil, domestic demand appears to be fairly stable. Household consumption increased by 0.6% in the first quarter of 2019 with three consecutive months of growth in retail sales. Pay growth has also remained relatively strong³. Wages before bonuses rose in the 3 months to May by an annual 3.6%, a level higher than most economic forecasts⁴.

Tourism, accommodation and food services sectors have been given a major boost due to the slide in the value of sterling against other major currencies. This Brexit impact is unwelcome for some manufacturers that rely on imported components and materials. However, a weak pound also stimulates "staycation" and draws in overseas tourists to the UK. In February 2019, VisitBritain published forecasts for 2019 inbound tourism that indicated an expectation that this year would come close to matching the record set in 2017 for numbers of overseas visitors (around 39m). Significantly though, it was expected that *spending* by overseas visitors in 2019 would set new records (over £24bn). The latest monthly report (March 2019) indicates that while overall visitor numbers have so far been slightly below this trend, *holiday* visits to the UK in the year ending March 2019 were 2% higher than the previous 12 months⁵.

The Wider International Economy

Although it tends to dominate discussion, there is more than Brexit influencing the UK economy at present. Indeed, depending on the outcome of the negotiations, the UK's relationship with the rest of the world is likely to be much more significant in future. Of course, Brexit and the world economy are linked – the EU, for instance, has only just recently concluded new trade deals with Vietnam and the countries that constitute the trade group MERCOSUR (Argentina, Brazil, Paraguay, Uruguay) with commitments on both sides to reduce duties and tariffs on goods from EU countries⁶. This adds to existing Brexit complexities involving re-framing trade relationships globally not only involving the UK but also existing agreements negotiated by the EU.

Growth in the global economy continues to be sluggish⁷. Year on year growth in world output is expected to slow from 3.6% in 2018 to 3.2% in 2019. Key factors inducing this trend include the effects of BREXIT, but as noted above, the escalation of trade tensions between the US and China arising from further increased tariffs on Chinese imports to the US and retaliations from China on US imports have impacted negatively on the global economy. Rising geopolitical tensions in oil-producing countries adds to uncertainties affecting energy prices.

First quarter 2019 growth in the Euro area was 0.4%, but analysts argue that this has been inflated also by stockbuilding on the European side in response to Brexit uncertainties. Growth in the second quarter is anticipated to be lower. In the US, GDP grew by 0.8% in quarter 1 of 2019 and the latest projections suggest 2019 growth could achieve 2.6%. Japan however continues to experience very low rates of year-on-year growth – anticipated 0.9% in 2019 overall. Weakening external demand combined with escalating tariffs have clearly impacted on China where GDP growth rates have declined annually from 6.8% in 2017 to 6.6% in 2018. Latest projections suggest continuation of this downward trend to 6.2% for 2019.

CORPORATE CHANGE IN CUMBRIA: APRIL-JUNE 2019

The second quarter of the year has seen considerable reported activity on the jobs and investment front in the County (see Tables 1 and 2). Despite the dominance of Brexit in the political arena, this issue has been cited very little in the reasons given for jobs being gained or lost and investment decisions in the most part appear to have been acted upon.

Of course, some expansion plans may have resulted from increased demand for products and services due to the depreciation of sterling – in part an indirect effect of the UK’s invoking of Article 50 of the Treaty on European Union to leave the EU. The latter, along with other causes, will be one of the reasons for the boost to the tourism sector apparent in the number of reported jobs gained (220). Due also to more favourable weather and predicted hot summers in future, the level of staycations is increasing and this is leading to investment and new jobs in the hotel and leisure sectors (see Lake Windermere Cruises, The Lake Distillery, The Waterhead Hotel, Holiday Inn Express, Leisure Resorts and Hinton Group). Food services are also a beneficiary of increased tourism in the County (see KFC, Costa Coffee and Bruce and Luke). The Lakes Distillery combines both tourist attraction and dining facilities and as such has been praised by the APC (Alternative Parcels Company Ltd) for its use of distillery tours to promote its products. In May, the company won the APC Growth Award for the North of England and was runner-up in the national awards. It has also secured funds of £5.35M to invest further in its products increasing the amount of single malt whisky that can be laid down for the future, propelling growth and new product sales (IC, 10.5.19 and 25.6.19).

The depressive impacts of austerity on the British economy are also no longer apparent in the reported figures on jobs gained and lost in the County. For example, a number of retail stores (see M&S, Lidl) and wholesale suppliers of parts and equipment (see Lloyd Ltd, Taylor & Braithwaite, Trust Ford, Aspatria Framers) have been investing in new premises. This investment is

also county-wide (Ulverston, Workington, Carlisle, Sandford, Carlisle and Longtown, respectively). Lidl has said that the new store in Workington “forms part of the company’s growth plans to open 50 new stores a year across GB” (IC, 26.4.19).

This optimism is borne out in the Construction sector (360 reported job gains) with the house-builder, Story, announcing plans to deliver around 325 houses in Cumbria and Scotland in 2019 and to increase its building of houses to 450 per annum in the North West (IC, 26.4.19). Genesis Homes is investing £43.5M in building nearly 300 new homes in Cumbria. In West Cumbria, the construction sector has been given a boost following the announcement that Thomas Armstrong is about to build a £4.1M Buzz Station in Whitehaven, part of a wider initiative by BEC to help revitalise the town (IC, 29.5.19). It will be built on the site of the old bus station using low-carbon building techniques and, it is said, will create 360 sub-contractor roles. DSD Construction, a construction company itself, has built a new 6,570 ft² facility on Kingmoor Park North, Carlisle. The £1.5M facility includes an office block, training suite and 2,500 ft² garage to house its fleet of vehicles and equipment for road-surfacing, maintenance and plant hire (IC, 24.6.19).

The largest investment reported this quarter by a Cumbrian firm has been in the Transport and Communication sector. Stobart Group has raised just over £53M in bonds on the London Stock Exchange in order to fuel growth in its aviation and energy businesses. Flights from Carlisle Lake District Airport took off on the 4th July whilst the Group is also to be the new operator for Durham Tees Valley Airport. It plans to increase passenger numbers at that airport to 1.4 million, driving the creation of hundreds of new jobs (IC, 3.5.19).

The sector with the smallest number of reported job gains is Manufacturing. Nonetheless, reports of investment are many. It is not only the County’s big players (see Pirelli, Kimberley-Clark, Sellafield, James Cropper and Gilbert, Gilkes & Gordon Ltd) which are investing in new premises or equipment to drive growth but also many of the County’s smaller manufacturing firms

(see SIS Patches, Tweddle Engineering, Clark Door) and those in the nuclear supply chain (Createc, Forth Engineering and Cavendish Nuclear). Also, GSK which announced redundancies last year has launched a £500,000 Enterprise Fund to give grants to businesses in South Cumbria to meet up to 30% of the cost of projects that is expected to create permanent jobs. Any size of business can apply for a grant including start-ups and social enterprises and the scheme will be run by the Cumbria Business Growth Hub (IC, 29.5.19).

Even in the few cases where there have been reported job losses this quarter, it may be the case that the loss is associated with productivity gain (see Kimberley-Clark, Cumbria County Council).
