'Brecht and the Village of Figgate':

A critical contextualization of the origins and uses of a cultural materialist theory and the aesthetic strategies informing a series of consciously satiric, 'counter-hegemonic' paintings.

'Because cultural theory is about the way in which the specifics of works relate to structures which are not the works.'

In this analysis I will discuss the efficacy of Brechtian theory within the creation of contemporary satiric paintings. The presentation will analyse Brecht's critique of aesthetics, the application of the dialectic and the attempted creation of a 'New Realism' within contemporary art production.
